The value of such works should be minimum of 80% of the amount put to tender for the works mentioned in the notification with any Govt. or Semi-Government Organization issued by an officer not below the rank of Executive Engineer; (4) Copy of the PAN issued by Income Tax Department.

Access to the e-Tendering will be issued after scrutinizing the applications received from the Tenderers after due verification of the ORIGINAL CERTIFICATES only to the eligible applicants. Incomplete applications will not be accepted. The EMD should be in the form of Demand Draft drawn in favour of Comptroller, UAS, GKVK, Bangalore, shall be scanned to the e-Tender document and the original should be submitted to the undersigned in a sealed cover duly superscribing the name of the work and contractor address on or before **22-9-2011 up to 4.00 P.M.**
