Applications are invited in the prescribed form (Annexure-III) for the award of **'Dr. Kalayya Krishnamurthy National Award'** - 2024-25 for the Best Agricultural Research. The award will be presented on the occasion of Foundation Day, UAS, Bangalore scheduled to be held during October, 2025.

Eligibility : The award is open to all the Agricultural and allied Scientists working in Farm Universities/ICAR Institutes / Public Institutions in India whose research or adoption of new technology (concluded within a period of 10 years) preceding the date of consideration has resulted in the enhanced production of agricultural crops / economic wellbeing of farmers. The applicant should have attained the age of 45 years as on the last date of application. The award shall not be made to the same person twice.

The applicants fulfilling the eligibility criteria may submit six copies of their bio-data and the statements about their work / contribution (in the prescribed application form) indicating precisely the work carried out and its bearing on the agricultural production in the region / country.

Bio-data in the application format shall be sent through proper channel with recommendations of the Institutional Head along with a Demand Draft for Rs. 1,000/- (Rupees One Thousand only) drawn in favour of the Comptroller, UAS, GKVK, Bengaluru to the Director of Research and Member-Convener, University of Agricultural Sciences, Bangalore on or before **5th August, 2025**.
