I. Introduction

The Government of Karnataka under the Universities of Agricultural Sciences Act, 2009 and as amended in 2012, has established six Farm Universities in the state with a view to impart quality agricultural and horticultural education in Karnataka State. Among the Farm Universities, University of Agricultural Sciences, Bangalore (UAS, Bangalore) is the oldest, established during 1963 located at Gandhi Krishi Vigyana Kendra (GKVK) campus, Bengaluru. The University of Agricultural Sciences, Dharwad (UAS, Dharwad) was established in 1986 to cater to the education, research and extension requirements of the Northern parts of the Karnataka State. The University of Horticultural Sciences, Bagalkot (UHS, Bagalkot), was established during 2008 to cater the teaching, research and extension needs in horticultural sector. During 2008, the University of Agricultural Sciences, Raichur (UAS, Raichur) was separated out of the University of Agricultural Sciences, Dharwad with its headquarter located at Raichur to cater to the farming needs of the Kalyana Karnataka Region of the Karnataka State. During 2012, the fifth University was established at Shivamogga as Keladi Shivappa Nayaka University of Agricultural and Horticultural Sciences (KSNUAHS, Shivamogga) and this was carved out of UAS, Bangalore and UHS, Bagalkot. During the current year, a new University was established at Mandya as University of Agricultural Sciences, Mandya (UAS, Mandya) and this was formed out of UAS, Bangalore and KSNUAHS, Shivamogga.

These Farm Universities, have Master's and Doctoral Degrees in different disciplines. The eligibility for Master's and Doctoral Degree programme is a Bachelor's Degree and Master's degree (respective discipline) from farm science Universities, respectively.

Each University had a separate schedule of admissions to the Post Graduate Degree programmes for Master's Degree till 2014 and for Doctoral Degree till 2016. Thus, admitting candidates for these Post Graduate Degree programmes separately was causing lot of inconvenience to the candidates and Universities. Hence, from the academic year 2015-16, all the five Farm Universities decided to have a Common Post Graduate (PG) Admission for Master's Degree courses and UAS, Dharwad conducted the process of the admission. Likewise, from the academic year 2016-17, it was decided to include Doctoral Degree programme also under common admission process.

The Ministry of Education, Government of India (GOI), has established the National Testing Agency (NTA) as an independent autonomous and self-sustained premier testing organization under Society of Registrations Act, 1860 for conducting efficient, transparent and international standard tests in order to assess the competency of candidates for admissions to premier higher education institutions. To align with National Education Policy (NEP 2020) and reduce the burden on students for appearing in multiple entrance examination for admissions in AUs of ICAR and in Farm Universities of Karnataka, Coordination Committee of Farm Universities of Karnataka took an initiative to utilize the NTA scores for Master's and Ph. D admissions in Farm Universities of Karnataka from the academic year 2023-24.

The process of conducting the common admissions to Master's and Doctoral Degree programmes in constituent colleges of participating Farm Universities of Karnataka State has been entrusted to UAS, Dharwad for the year 2025-26. From the academic year 2022-23, it was decided to adopt the system of PG admission by considering the 50 per cent weightage of the NTA-ICAR Score and 50 per cent weightage of qualifying examination marks obtained in the Bachelor's and Master's degree programmes for admission to Master's and Doctoral degree programmes, respectively in various subjects of the respective Universities. It is decided to conduct a separate entrance examination for the stand-alone programmes, where NTA-ICAR streams are not matching. The detailed procedure for conducting Common Admission to the Master's and Doctoral Degree programmes in the Farm Universities of Karnataka State is furnished in this *Information Bulletin*.

IV A. Mode of ON-LINE Payment of Application Fees and Admission Fee

The candidate seeking admission/ Re-admission to the Post Graduate Degree Programmes (Master's Degree and Doctoral Degree) in the Farm Universities of the Karnataka State have to pay the **prescribed fees (both Application and Admission Fees) individually through the ON-LINE Transfer Facility provided on the WEBSITE: <https://pg-admission.kar.nic.in/>.**

IV.B. Duration, Medium of Instruction and System of Education for Post Graduate Degree Programmes

A. Master's Degree Programme

Minimum of two academic years (**4 Semesters**) and maximum of five consecutive academic years (*i.e.*, **10 Semesters**) from the date of admission. Further, the provision for re-admission is not allowed.

B. Doctoral Degree Programme

Minimum of three academic years (**6 Semesters**) and maximum of seven consecutive academic years (*i.e.*, **14 Semesters**) from the date of admission. Further, the provision for re-admission is not allowed.

C. System of Education and Medium of Instructions

Both the Master's and Doctoral Degree programmes are taught in English medium only under Semester system of education.

NOTE: The applicants may contact above listed Farm University Officials for any assistance during working hours of the Universities between **10-00 am** and **04-00 pm** on weekdays and between **09-30 am** to **12-00 noon** on **Saturday**.

V (b) Eligibility for Admissions to Master's Degree Programmes

1. Candidates should possess a Bachelor's Degree with a minimum OGPA of 5.50*/10.00 or its equivalent and in case of candidates belonging to SC/ST/Category-I, a minimum OGPA of 5.00**/10.00 from any recognized State/ Central/ Deemed Agricultural / Horticultural/ Forestry Universities & Other Farm Universities.
2. Candidate should produce character and conduct certificate issued by the Dean's of the respective Colleges of their Universities.
3. Domicile Requirement: Karnataka state domicile status - *a minimum seven years of study in Karnataka* is mandatory.

VI (b) Eligibility for Admissions to Doctoral Degree Programme

1. A Master's degree in the concerned subject or eligibility criteria furnished below (given by the respective universities) or an equivalent qualification from recognized State/ Central/ Deemed Agricultural/ Horticultural/ Forestry Universities & Other Farm Universities in terms of equivalent course duration, with minimum OGPA of 2.50/4.00 (for trimester system) or OGPA of 7.50/10.00 (for semester system). In case of candidates belonging to SC/ST/Cat-I, the minimum OGPA required is 2.00/4.00 (for trimester system) or OGPA of minimum 7.00/10.00 (for semester system) to be eligible to seek admission.
2. The candidate must possess a Master's Degree from any recognized State/ Central/ Deemed Agricultural / Horticultural/ Forestry Universities & Other Farm Universities under 10+2+4+2 system / scheme
3. The candidates who have studied under the trimester system and are seeking admission for doctoral Degree programmes are required to compulsorily submit the equivalent marks certificate (Master's Degree) obtained from their respective Universities / Institutions. These seats are over and above the notified seat matrix. These in-service candidates should apply **ON-LINE** within last date prescribed and **compulsorily** forward their **Filled-In Applications** through their employer and should reach the Registrar, UAS, Dharwad on or before **30-08-2025**, failing which their application shall not be considered. In-service candidates also need to apply either for **concerned NTA-ICAR STREAM** for AICE(Ph.D)–2025 conducted by National Testing Agency (NTA), The Ministry of Education, Government of India (GOI) or **stand-alone stream requiring Entrance test conducted by the Farm universities** depending on their discipline [Ref.Table.No.VI (a & b)]. 7. 3. Change of subjects opted shall not be permitted after final submission of the ON-LINE application.

- a. If the Aggregate or total marks (NTA-ICAR or Farm University Entrance 50% weightage and qualifying exam 50% weightage) of more than one candidate are equal, then tie(s) is/are resolved in accordance with the following criteria.
 - 1) The candidate securing more marks in NTA-ICAR or Farm University Entrance Examination is to be put in the higher rank.
 - 2) In case marks mentioned above are also equal, then the candidate senior in age is to be put in higher rank.

- e. Candidates seeking admissions under SPECIAL CATEGORY QUOTA have to appear in-person for physical verification of original documents and counseling on the notified dates at **UAS, Dharwad main campus only** (Ref. Calendar of events on Page 02)

IX. Re-Admission

Candidates seeking re-admission to Master's/ Doctoral Degree programmes shall apply through **ON-LINE** process on or before specified last Date: **30-08-2025** (Ref. Calendar of events on Page 02 for confirmation) and they need not write the entrance examination. But they have to produce original documents related to their first admission/ latest Cumulative Grade Point Average (CGPA) card during physical document verification at their respective University (Ref: Calendar of events). The other conditions for re-admission are as per the academic regulations of the respective Farm Universities. Duration of Examination will be **75 Minutes (9.30 am to 10.45 am)** with Multiple Choice Questions with four options (MCQ's) for 100 marks.

- The Entrance Examination for stand-alone programmes will be conducted with the technical support of University Centralized External Examination Unit, UAS, Dharwad.

XI. Important Instructions to the Candidates

- Check eligibility criteria of each University before choosing subjects in selected streams of Master's Degree [Ref. V (a) to V (c)] and for Doctoral Degree programme [Ref. VI (a) to VI (c)] for which admission is sought. (Check the eligibility of concerned University)
- Instructions for candidate appearing for Farm Universities Entrance Examination for stand-alone programs.
 - Admission/ Hall Ticket Number shall be allotted to the Candidates and be placed on the website of Common Post Graduate Admissions 2025-26 (<https://pg-admission.kar.nic.in/>) on **01-09-2025** onwards (Ref. Calendar of Events on page 02). The candidates should download it and invariably enter the same on OMR sheet used for answering questions.
 - Candidate must produce any of the original photo ID proof issued by the University or State/ Central Government at the time of Entrance Examination. It may be ID card issued by College last attended, Passport, Aadhaar Card, Driving License or Voter ID card to establish the identity.
 - Request for change of center for appearing in the Entrance Examination shall not be entertained.
- Candidates have to pay the prescribed **fees individually through ON-LINE transfer facility provided on the WEBSITE – <https://pg-admission.kar.nic.in/>** only after the allotment of seats. After the last date is over, the unfilled seats in various categories shall be included in the notification for the next round option entry. The Master's / Doctoral Degree candidates who opt for any changes in allotted Subject / College / University during second and subsequent ON-LINE allotment need to pay the difference in fees, if any, at the respective Universities.

4. Fees once paid shall not be refunded. However, if a candidate cancels his/ her admission, the caution money paid shall be refunded after following procedures laid down in the respective University.
5. If a candidate gets his/her admission cancelled during First round of seat allotment of common PG admission due to allotment of seat under ICAR quota, the fee will be refunded by following established procedures adopted in the respective Universities. This does not apply to subsequent rounds of seat allotment of Common Post Graduate Admissions in farm Universities of Karnataka.
6. The last date for uploading of Bachelor's Degree **OGPA** card in PDF format only (Resolution: 200 dpi to 300 dpi) / Category / Income Certificate/ Kalyana Karnataka / any other relevant certificates by candidates for Master's Degree is **10-09-2025** and likewise for uploading Master's Degree OGPA card in PDF format only (200 dpi to 300 dpi)/ Category/ Income/ Kalyana Karnataka / any other relevant certificates by candidates / applicants for Doctoral Degree is **18-10-2025** (Ref. Calendar of Events on page 02).
7. **Request for change of preference for disciplines/ subjects after final submission of the application shall not be entertained.**
8. Candidates should provide the accurate e-mail ID, Aadhaar Number, Contact Phone Number (Mobile Phone Number) and permanent address. Any request regarding changing of Mobile Number and E-mail ID will not be considered at all.
9. Phone number and e-mail ID once given by the candidates in the application form during filling up of the **ON-LINE APPLICATION** should not be changed / altered as all the instructions, SMS alerts during the **ON-LINE COUNSELING PROCESS** will be communicated to the candidates to the **same Contact Mobile Phone Number and e-mail ID.**
10. Any other relevant documents prescribed have to be issued by the Registrar of the respective Universities.
11. Overall Grade Point Average (**OGPA**) Card / Provisional Degree Certificate (**PDC**) must be issued only by the **REGISTRAR** on or before the last date prescribed for uploading the said documents.

XIII. Mode of Admissions to Special Category

In addition to regular seat intake (as per **Seat Matrix**), seats shall be allotted to the special category candidates for Master's/ Doctoral Degree programme as below:

1. The seats reserved for **Special Categories** are *over and above* the University intake.
2. For children of Ex-servicemen (EXS) 2.50 % of the seats are reserved, 1.50% for Defense Personnel (DEF) and 1.00% for **Paramilitary Personnel (PP)/ Central Armed Police Force (CAPF)**.
3. For Differently-abled / Physically Challenged / PH category 5 % of the seats are reserved.
4. Seats for the above two categories shall be allotted based on the choice of subject by the candidate and merit (50% of Qualifying Examination + 50% weightage of NTA score **or** 50 % of Entrance Examination marks, whichever is applicable) **not exceeding one seat per subject per college**.
5. Seats for NCC, NSS, Sports and Cultural activities are reserved as given in Annexure I to Annexure V) of each University Seats for aforesaid four categories shall be allotted based on choice of subject and merit (in terms of their achievements) not exceeding one seat per subject per college. For candidates who have excelled in Sports, NCC/NSS and Cultural activities during the Qualifying Degree programme, enclosing of attested certificate to claim the seat is mandatory.
6. After physical verification, the seat allotment under Special category shall be done in the following categories viz., EXS, DEF, CAPF, Paramilitary Forces, Physically Challenged, NCC, NSS, Sports and Cultural in that sequence by Inter-University Admission Committee at UAS, Dharwad (Ref. Calendar of Events on page 02).

XIII (a). National Service Scheme (NSS)

Allotment of seat under **National Service Scheme (NSS) Quota**: candidates should have served as NSS volunteers for at least two years or as prescribed in their Under Graduate level. NSS should be a course in the respective University. The allotment of seats shall be in the following order of achievements:

- a. Recipient of award as Best NSS Volunteer at National Level.
- b. Participation in National Republic Day Parade.
- c. Recipient of award as Best NSS Volunteer at State Level.
- d. Participation in State Republic Day Parade.
- e. Prizes won in National Integration Camp (NIC)-NSS camps in the order of first, second and third prizes.
- f. Prizes won in special camps in the order of first, second and third prizes.

XIII (b). National Cadet Corps (NCC)

Allotment of seats under **National Cadet Corps (NCC)** quota for having participated during Under Graduate (UG) Degree programme (Secured certificate/s either as per the course curriculum or outside the course curriculum) shall be in the following order:

1. Prizes won at National Republic Day parade in the order of first, second and third prize.
2. Participation in National Republic Day parade.
3. Participation in TSC/NSC/YSC at DG-NCC level and won prizes in the order of first, second and third prizes.
4. Participation in TSC/NSC/YSC at DG-NCC level.
5. For 'C' certificate holders in the order of A, B and C grades.
6. For 'B' certificate holders in the order of A, B and C grades.
7. Participation in camps conducted by DG-NCC.
8. Participation in camps conducted by DDG-NCC.

XIII (c). Sports / Cultural Activities

Candidates who have represented in various **Sports and Cultural Events**, their achievements during Under Graduate (UG) and Post Graduate (PG) Degree programmes will be considered for admission to Master's and Doctoral Degree programmes, respectively in the following order:

1. Prizes won at International level in the order of Gold, Silver and Bronze medals.
2. Representing the country by participating in international events.
3. Winning any medal at National level by representing the State in the order of Gold, Silver & Bronze medals.
4. Winning any medal at Inter-University level by representing the University in the order of Gold, Silver & Bronze medals.
5. Representing the state in different events.
6. Representing the university in a state level or national level sports.

NOTE:

The **Sports and Cultural Events** recognized by **Association of Indian Universities (AIU)**, Sports Authority of India, National Sports Federations of India, and ICAR-All India Inter-Agricultural-University Sports and Cultural Events shall only be considered.

- a. Priority will be in the order of Gold, Silver and Bronze Medals.
- b. In the event of tie among the eligible candidates, number of medals secured/ number of representations in the University and at the next level the marks obtained in the entrance examination in the order shall be taken into consideration to prepare the merit list.

XIV General Instructions for the Candidates

- Reservation of seats shall be as per the orders issued by the State Government from time-to-time as shown in the Seat Matrix for each University.
- One seat is reserved over and above for Anglo-Indians in each University.
- Thirty per cent of seats of total intake capacity in farm universities of Karnataka are placed at the disposal of ICAR for allotment to the candidates from outside / within Karnataka state through ICAR counseling.
- A candidate who has studied from First Standard to Tenth Standard in Kannada Medium School outside the Karnataka state shall be treated as Horanadu Kannadiga.
- Horanadu and Gadinadu Kannadiga candidates, Sons / Daughters of Kannadigas including Government of India (GoI) employees studying outside the Karnataka state are eligible as per the eligibility criteria set by Government of Karnataka (GoK) from time to time.

XV (a) Seat allotment and conversion of vacant seats

Based on the merit and priority of options exercised by the Candidates, the first round of allotment begins. The computer programme will allot the seats and while allotting the seats in the **First Round** at any stage, the seat allotted if any, will automatically get cancelled upon allotment of a seat in the subsequent discipline and such cancelled seat will be considered for allotment of a seat in the next iteration. Therefore, multiple iterations may take place in the **First Round**. The computer programme will stop the allotment only if the last seat is allotted or when it reaches the last rank in each discipline, whichever is earlier. That means the candidates will always be climbing upwards both in options and in roster. The order of allotment will be repeated in the **First Round** until there is no change in the allotment of any candidate.

XV (b) Seat allotment in subsequent rounds

If a reserved category candidate is allotted with a General Merit seat, then a reserved category seat becomes vacant. Such seats are treated as '**Consequential Vacancies**'. These consequential reserved category vacancies that arise during the **Second Round** of allotment will remain under the same categories and will be offered only to the candidates belonging to the same reserved categories. All consequential vacancies which arise in different rounds will be considered for allotment as GM.

XV (c) Seat allotment under Kalyana Karnataka (KK)

If there are no candidates available in reserved categories under **Kalyana Karnataka (KK)**, the seats will be converted to **Kalyana Karnataka General (KKG)** and when there are no candidates in KKG, the seats will be converted to **General Merit (GM Non-KK)**.

1. Tuition and other course fees paid by the students admitted to the University shall not be refunded under any circumstance.
2. The above fees are subject to change from time to time and across Universities.
3. In case admission is cancelled, only caution money will be refunded.
4. Fees reimbursement from Social Welfare Department is applicable only to SC / ST students of Karnataka State. However, SC / ST students from other State have to pay the fees prescribed for the GM / Others in advance and there after get the fees reimbursement from their respective State in time.
5. The SC/ST students whose parental income is up to Rs.2.50 Lakhs per annum have to provide an undertaking to return the amount reimbursed by the Social Welfare Department to the respective University/ Colleges. After the admission, these students have to apply through Online/ upload their applications with required documents to the Social Welfare Department for reimbursement of fee. However, reimbursement amount will be credited directly to the students account by Social Welfare Department.
6. To claim the Fee reimbursement benefit all eligible SC/ST students should apply before due date to the Social Welfare Department along with the relevant documents and hard copy of the same has to be submitted in time to the Office of the respective Deans failing which they have to pay the full fee.
7. The SC/ST Students whose parental income is from Rs.2.50 to 10.00 Lakhs per annum have to pay 50% of the total fee. The remaining 50% of total fees will be reimbursement from University SCSP/TSP grants.
8. The SC/ST students whose parental income is more than Rs.10.00 lakh shall have to pay the Fees of GM/ Others at the time of admission.
9. SC / ST students who are eligible to get their fees reimbursement from the Social Welfare Department. If any fees differences, that amount will be reimbursed under SCSP / TSP Grants subject to the availability of the budget in the Universities.
10. Cat-I / OBC / Minority and other students will have to pay the full fees prescribed for the GM students. However, these students have to claim the admissible fees from their respective BCM / Minority department.
11. The Hostel facility for admitted students will be provided upon payment on first come first service basis.





- Accessible through a simple, digital 2-page application via PM-Vidyalaxmi Portal (<https://pmvidyalaxmi.co.in>).
- Loan covers: tuition fees, hostel fees, mess charges, laptop purchase and living expenses.
- Repayment period: upto 15 years, excluding total course duration+ 1 year moratorium.
- Interest rate cap: EBLR (bank rate) + 0.5%.

Subsidy and Guarantees

- 3% interest subvention for loans upto ₹10 lakhs, if annual family income is ₹4.5 lakhs to ₹8 lakhs.
- 100% interest subvention under PM-USP CSIS, if annual income is \leq ₹4.5 lakhs.
